(the "**Company**" and together with its subsidiaries, the "**Group**") wishes to announce that Jadeite Capital had on 5 April 2017 exercised 1,800,000 Consolidated Warrants held by it at the exercise price of S\$0.09, resulting in the allotment and issuance of 1,800,000 new ordinary shares in the capital of the Company ("**New Shares**") to it on 6 April 2017, and that Mr Christopher Chong Meng Tak had on 5 April 2017 exercised 4,732,000 Consolidated Warrants held by him at the exercise price of S\$0.09, resulting in the allotment and issuance of 4,732,000 New Shares to him on 6 April 2017.

The New Shares will rank *pari passu* in all respects with the existing ordinary shares of the Company.

Pursuant to such exercise of 6,532,000 Consolidated Warrants and the allotment and issuance of the New Shares, the issued and paid-up share capital of the Company has increased from 841,494,845 to 848,026,845 ordinary shares.
